## **Background information**

The Climate Change Act commits the UK government by law to reducing greenhouse gas emissions by at least 100% of 1990 levels (net zero) by 2050. In addition, from April 2023: for all new contracts above £5 million per annum, the NHS requires suppliers to publish a Carbon Reduction Plan.

Wardray Premise Ltd is an SME and does <u>not</u> have an NHS contract in excess of £5m. However, we do bid for parts of contracts via the NHS Framework, where the total contract exceeds this level (e.g. MR patient monitoring).

Our commitment to achieving Net Zero:

Wardray Premise Ltd is committed to achieving Net Zero emissions by 2050 at the latest.

## **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gas emissions that have been produced in the past and were produced prior to the introduction of specific strategies to reduce emission. Baseline emissions are the reference point against which emissions reduction can be measured.

Wardray Premise Ltd have set 2023 as their Baseline Year, and they have appointed a third-party consultancy firm (Green Small Business) to assist with this work, advise on data collection, establish a baseline of total emissions for 2023 and ensure compliance with Procurement Policy Note 06/21.

This will include emissions from

- all Scope 1 & 2 emissions arising from company premises and vehicles.
- Scope 3 emissions from business travel.
- Scope 3 emissions from staff commuting.
- Scope 3 emissions from waste.
- Scope 3 emissions from upstream and downstream transportation.

Under the NHS's net zero roadmap we will report our full carbon footprint by the end of 2024.

Our commitment is to update our carbon footprint, produce emissions reduction targets and conduct annual reviews.

Examples of some of our completed carbon reduction projects include:

- Hybrid working
- LED lighting & PIR lighting controls
- · Green energy suppliers; and
- Cardboard waste recycling.
